<b>What is the overall deductible?</b>	For <u>network providers</u> \$2,600 individual or \$5,200 family; for <u>out-of-network providers</u> \$6,400 individual or \$12,800 family.	Generally, you must pay all of the costs from <b>providers</b> up to the <b>deductible</b> amount before this <b>plan</b> begins to pay. If you have other family members on the policy, the overall family <b>deductible</b> must be met before the <b>plan</b> begins to pay.
<b>Are there services covered before you meet your deductible?</b>	Yes. <u>Preventive Care</u> and <u>Wellness</u> are covered before you meet your <u>deductible</u> .	This <b>plan</b> covers some items and services even if you haven't yet met the <b>deductible</b> amount. But a <b>copayment</b> or <b>coinsurance</b> may apply. For example, this <b>plan</b> covers certain <b>preventive services</b> without <b>cost-sharing</b> and before you meet your <b>deductible</b> . ### Does this plan provide Minimum Essential Coverage? **Yes**

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
